To our Valued Motor Carrier Customers,

Please be advised that we have received the below information from the Port of Los Angeles with regard to disposition of Hanjin empty containers. Hanjin empties are able to be terminated if they are leased. Container leasing companies are willing to accept their containers back from Hanjin.

How to do this:

- 1) Look for non-HJCU prefix containers.
- 2) Use the below guide to determine the leasing company owner and contact information.
- 3) Email the leasing companies the entire container prefix, number and city location of box. They will email you back authorization and where to terminate their box.

If you are unsure of the owner, you can also use track-trace.com to find out what company owns the container:

HJCU	if blue Hanjin owned box with HJCU, there is no action available other than holding empties until an alternate plan is in place. If you have a loaded Hanjin container, you will need to get the contents unloaded and into another ocean line box asap.
